It is an ultra slim scope with an outer diameter of 13.2 mm and has a 3.7 mm biopsy channel making therapeutic procedures more fruitful. Colonoscopy is a procedure that allows the physicians to see the inside of large intestine and it is done with a flexible camera called scope. This test is done to check out symptoms like bleeding, as well as look for polyps and possible signs of colon cancer.
